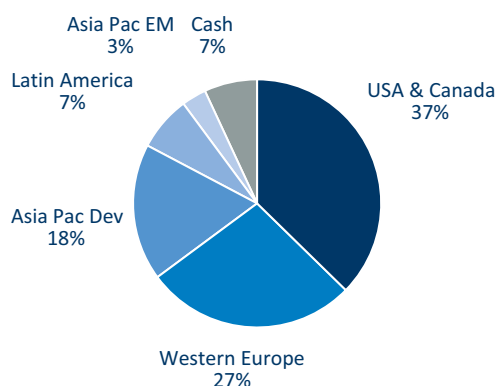

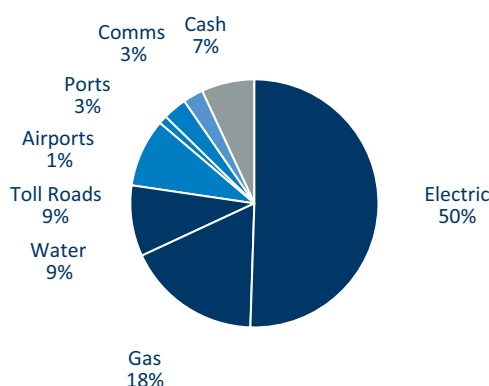

REGIONAL BREAKDOWN



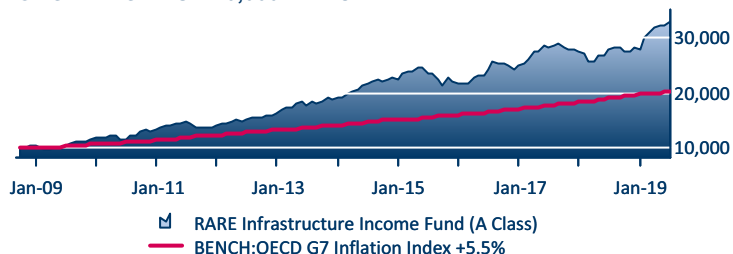
SECTOR BREAKDOWN



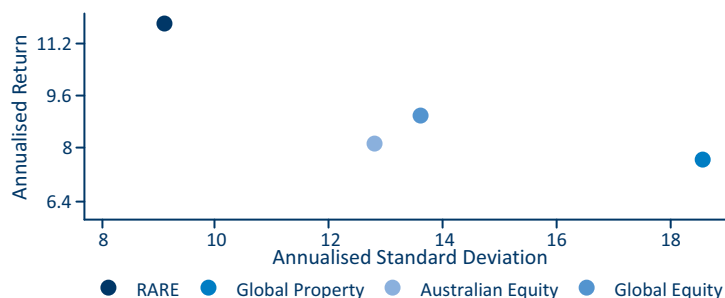
