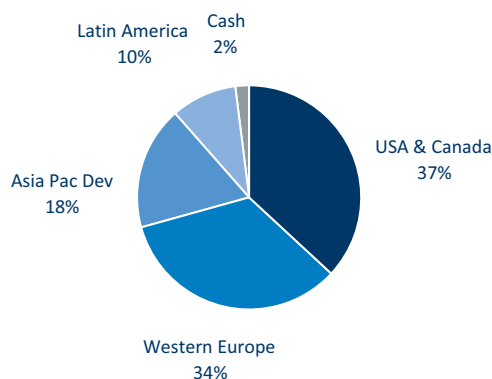

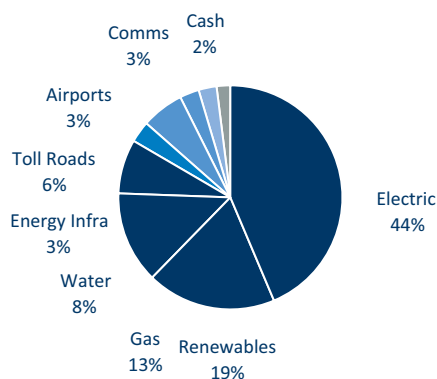

REGIONAL BREAKDOWN



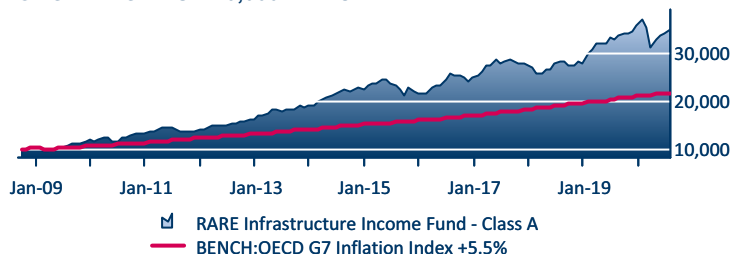
