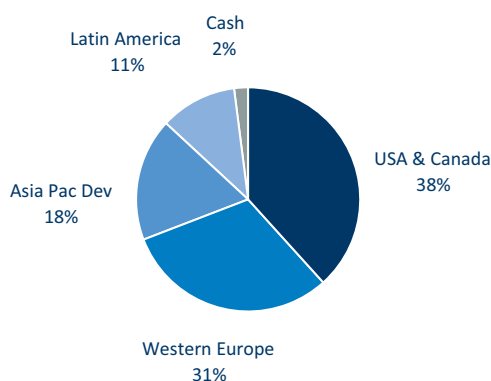

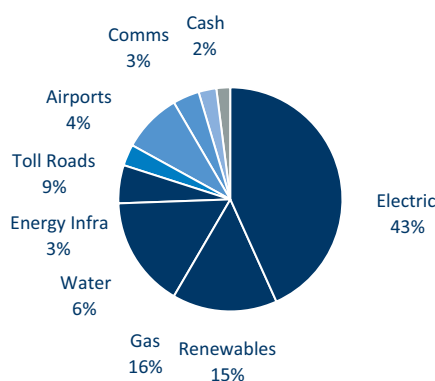

REGIONAL BREAKDOWN



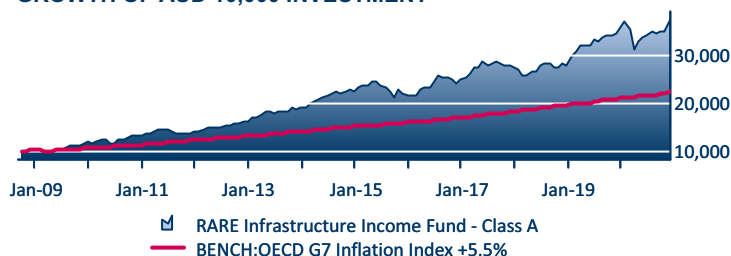
