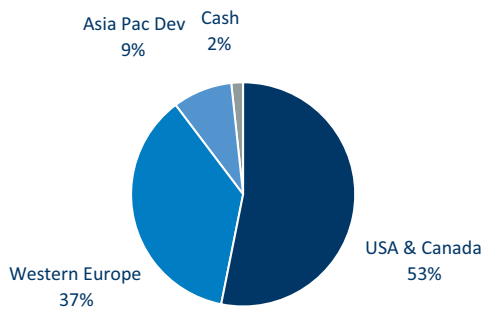

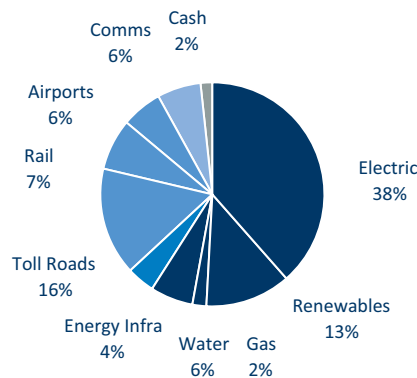

### REGIONAL BREAKDOWN



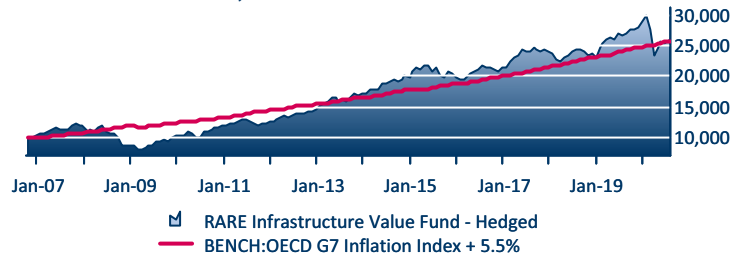

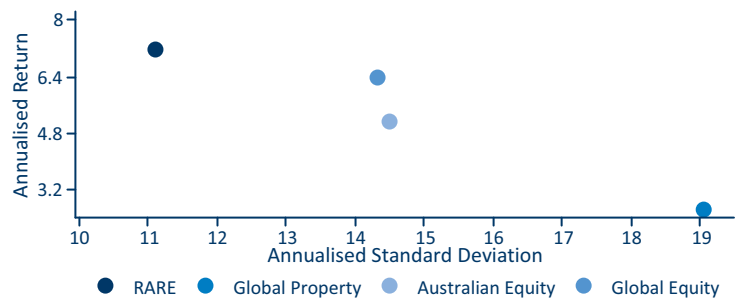
